The CADDRA Research Day is the only national meeting focused on ADHD research in Canada. The meeting brings together researchers, clinicians and students from a wide variety of disciplines to share knowledge, discuss innovative research findings, and develop new collaborative research projects in ADHD.

SUBMISSION DEADLINE: EXTENDED DEADLINE! June 8, midnight ET

No changes may be made to your submission, including author information, after the deadline.

Abstract Submission Categories

ABSTRACT SUBMISSION INSTRUCTIONS/GUIDELINES

Submitting an Abstract

- Go to caddra.societyconference.com
- Click on the submission tab
- Click on "Submit here to present at CADDRA 2020"
- Select the type of session you would like to present (Senior/Junior Researcher Oral Presentation, Junior Researcher Oral Presentation or Poster) and follow the instructions
- Industry* submissions will require payment of a \$500 administrative fee if accepted.
**Presenting authors that are employed by a commercial entity are considered industry posters. In addition, presenting authors that are affiliated with a commercial entity and are submitting a poster about a brand specific drug on behalf of the entity should be submitted as an industry poster.*

Abstract Character Limit

- **Title** character limit: **200 characters**, excluding spaces
- **Abstract Description** character limit: **250 words**.

Authors

- To qualify for authorship, individuals must have made substantial contributions to study conception and design; and/or substantial contributions to acquisition of data; and/or substantial contributions to analysis and interpretation of data.
- Do not list authors or commercial relationships in the body of the abstract.
- Please consult with your co-authors on how their names should appear prior to submission. You will not be able to make changes after the submission deadline.
- All authors must disclose research funding at the time of submission.

Abstract Content

- Take special care when entering your title, as it will be **published exactly as submitted**
- Titles should be brief, clearly indicating the nature of the presentation
- When entering the title, use mixed case (do not use all caps OR all lowercase). Do not put a period at the end of the title. For example:

Correct:

This Is a Properly Formatted Abstract Title

Incorrect:

THIS IS AN IMPROPERLY FORMATTED ABSTRACT TITLE

This is an improperly formatted abstract title

T his is an imp roperly formatted abstract title.

- Abstracts should include objective information based on scientific methods generally accepted in the medical community
- Abstracts should include up-to-date data drawn from scientifically valid sources
- Abstracts must be accompanied by [three learner-centered objectives](#) and include key words
- Define special or unusual abbreviations the first time they are used.
- Generic drug names should be used.
- Organize content in sections as follows:
 - Background/Purpose:** Background or statement of purpose
 - Methods:** Methods, materials, and analytical procedure used
 - Results:** Summary of the results in sufficient detail to support conclusion (never “results will be discussed”)
 - Conclusion:** Conclusions reached

Disclosure Policy

As a CME provider CADDRA requires that individuals (presenters/speakers, moderators, reviewers, authors, and planners) disclose to CADDRA and the audience any *relevant relationships* that have the potential to affect the content of CME. Accepted presenters will be required to complete disclosure forms.

Presentation Formats

- Abstracts can be submitted for Senior Researcher Oral Presentations, Junior Researcher Oral Presentations and Poster Presentations
- The presenting author need not be the first author, but must be a listed author
- As English is the designated language for the meeting, the presenting author is required to speak English when presenting.
- Oral presentations are open to Canadian-based researchers only. Poster presentations are open to Canadian and international applicants.

Revisions

- You may return to the online submission site to revise your abstract until **June 8, midnight ET**
- Proofread carefully to avoid errors prior to submission
- Selected abstracts will be published online *exactly* as submitted.

Awards

- Junior Researchers (undergraduate to post doctorate level, residents) can apply for 10 Kids Brain Health Network (KBHN) Junior Researcher Awards of \$300 each
- KBHN/CADDRA ADHD Research Day Registration Awards will be presented to the 40 top ranked student oral/poster presentation applicants. Awardees will be provided with complementary registration to the 2020 virtual ADHD Research Day. A limited number of registration awards have been allocated for international presenters.

ABSTRACT REVIEW AND NOTIFICATION

Abstract Review

- After the submission deadline, completed abstracts will be peer reviewed by the Planning Committee.
- Incomplete abstracts cannot be processed and will *not* be reviewed.
- Abstracts will be reviewed on a rolling basis by members of the planning committee through a blinded review process, i.e., reviewed without knowledge of the author(s), institution(s), or disclosure information.

Abstract Acceptance/Rejection Notifications

- The submitting author will receive notification of acceptance/rejection.
- Accepted presenters will be required to submit a conflict of interest disclosure statement, a CV and a headshot.

REGISTRATION

- Submission or acceptance of an abstract *does not register* you. All presenting authors are required to **register and pay by August 31**.
- CADDRA cannot provide registration; however student/trainee grants will be available (see awards section)

PART 2: ABSTRACT PRESENTATION

ORAL PRESENTATIONS

Senior Researcher Oral Presentation

- Presenter must be working in Canada
- Data and results should be completed; expected data or results to be determined are not acceptable.
- 30 minute duration, including Q&A
- 1 speaker

Junior Researcher Oral Presentation

- Presenter must be working in Canada
- Data and results should be completed; expected data or results to be determined are not acceptable.
- 15 minute duration, including Q&A
- 1 speaker

POSTER PRESENTATIONS

Poster

- Canadian or international content
- High quality methodology and literature review abstracts may be submitted.
- Data and results should be completed; expected data or results to be determined are not acceptable
- All attendees will be able to view posters as part of a virtual poster hall
- Posters will be also be published as ePosters on the CADDRA eLearning portal (adhdlearning.caddra.ca)

Poster Specifications

- Posters must include title, author, background, methods, results, and discussion of study limitations and clinical and/or theoretical implications
- Financial disclosures and organization logos should be prominently displayed
- Screen prints, charts, drawings, photographs, and other graphics, along with text, to illustrate the presentation are encouraged but should be at a high resolution for optimal viewing
- Lettering should be simple, bold, and easily legible
- Poster presenters must register for ADHD Research Day by July 31
